Voluntary Safety Net Benefits

- Short & Long Term Disability: Providing qualified participants a portion of their compensation when unable to work due to a covered approved disability.
- Accident Insurance: Offers a cash payout, unrelated to other income, when your income is affected by an accident covered under the policy. (Also includes an additional life insurance payout if deceased by a covered accident.)
- Critical Illness and Cancer Policy: This policy offers a cash payout when diagnosed with a covered illness. (Also includes an additional life insurance payout, if deceased by covered illness.)
- Additional Term Life Insurance: Allows employees to buy-up from the company-provided Life Insurance. Coverage is also available for spouses and children.

Other Voluntary Options

- **Legal Shield**: Provides legal assistance, planning, and discounts for in-network attorneys.
- ID Shield (Identity Theft Program): Provides identity theft protection assistance for you and your family.
- Two Pet Care Discount Plans: Offering both veterinary discouts at 25% and pet prescriptions at wholesale pricing, available at most large-network pharmacies.
- 401(K): Offers retirement savings plan, contribution matching by TNAA.

Company Paid Benefits
